- 2½ semesters** (February to June and July & August and September to January) – **max. 10 high school credits**

- 1 semester – max. 4 high school credits**  
Tuition: non-refundable as of registration  
non ESL \$8,340 – ESL \$9,540
- ½ semester** (July & August) – **max. 2 high school credits**  
Tuition: non-refundable as of registration – non ESL \$4,170 – ESL \$4,770
- Short term** (monthly) – **no high school credits**  
Tuition: non-refundable as of registration – non ESL \$1,390 – ESL \$1,590

Upon the student's arrival, Scholars' Hall shall make a determination of English as a Second Language instruction regarding its necessity, amount, duration and location. Scholars' Hall reserves the right and option to change, increase, decrease or discontinue ESL instruction according to Scholars' Hall's evaluation of the student's ability to meet the Ontario Ministry of Education's curriculum performance expectations. ESL instruction and services additional to the regular day school fees will be billed separately. Prior to the release of all reports; credits; or promotions, any balance owing of the total fees must be paid in full. At Scholars' Hall Inc. all credits, marks, and/or promotions are earned only after any balance owing is paid in full. Method of payment has no bearing on the conditions of this registration contract. This registration contract is also binding with any incorporated business owned by either or both signers and collection can occur directly against the incorporation. Failure to communicate with Scholars' Hall Inc. if payment will be late will result in your account being forwarded for collection of the full tuition. Service can/will be immediately suspended. A stop payment or NSF cheque is a late payment and \$50 is charged. This contract replaces and supersedes any prior stated or implied agreement. Any balance owing is subjected to a 2% per month (24% annually) interest charge.

I/We [Parents/Guardian/Agent] acknowledge that Scholars' Hall Inc. has the unreserved right to fill any/all places at Scholars' Hall, prior to the receipt of the full tuition or the non-refundable dates stated in the Refund Policy, whichever occurs first. Scholars' Hall will inform Me/Us [Parents/Guardian/Agent] and I/We can proceed with full payment or withdraw will full refund of all monies received by Scholars' Hall.

**Refund Policy :**

For students registering for less than 2 full semesters, payment of full tuition is required at registration and is totally non-refundable as of registration.  
 For students registering for 2 full semesters or more, payment of \$3,000 is required prior to Visa Acceptance Letter being issued.  
 Prior to non-refundable dates: Receipt of Original Canadian Embassy letter of visa denial will result in refund of all monies received less \$500.  
 On or after non-refundable dates: Total tuition is non-refundable. No refund of any portion or reduction of any unpaid obligation/balance will be granted even if your child does not maintain good attendance for any reason, including but not limited to inability to obtain a student visa, absenteeism, suspension, withdrawal, expulsion, or illness. Scholars' Hall reserves the right to expel a student, without prior notice, at any time, or for any reason(s) stated or implied in the school's "Standards of Good Conduct and Teachability" and/or the school's "Order and Discipline Policy".

I/We [Parent(s) and/or Guardian and/or Agent] acknowledge that I/we, jointly and severally, have an unconditional obligation to pay the full year's tuition and any/all other fees, charges, levies and assessments according to the conditions of this contract as may be rendered, from time to time, by Scholars' Hall Inc.
